



# Establishment:

NGO Affairs Bureau (NGO AB) was established in 1990 through an administrative order of the Government of Bangladesh. Initially, it was located in the Public Division of the President's Secretariat, and later on, in the Cabinet Division. In 1991, with the re-introduction parliamentary form of government, the NGO-AB was placed under the Prime Minister's Office as a regulatory body of the NGOs with the status of a government department. Activities of the NGO AB as well as NGOs were governed by two ordinances namely, the Foreign Donations (Voluntary Activities) Regulation Ordinance, 1978 and the Foreign Contribution (Regulation) Ordinance 1982. The prime objective of the bureau is to provide one-stop services to NGOs, registered under the Foreign Donations (Voluntary Activities) Regulation Ordinance, 1978 to operate in Bangladesh with the assistance of foreign donations. Mentionable, these two ordinances have been replaced by the new Act titled. ' বৈদেশিক অনুদান (স্বেচ্ছাসেবামূলক কার্যক্রম) রেণ্ডলেশন আইন, ২০১৬' (in English - the Foreign Donations (Voluntary Activities) Regulation Act, 2016) passed by the Parliament on 13 October 2016. Rules under the new act will be formulated in due course. In addition, bureau facilitates the activities of NGOs in the country, and ensures their accountability to the state, as well as to the citizenry of the country. Bureau communicates with the line ministries for views on the project proposal as it is expected that project proposal should be well aligned with national priorities, Vision 2021 and internationally agreed goals, SDGs. It should also avoid duplication of interventions and target the marginalized and vulnerable people. During emergency situation like flood or cyclone, bureau approves project proposals in 24 hours mainly for distribution of relief materials. Local administration of affected area is kept informed while approving emergency project proposal. Acceptance of one time foreign contribution is usually allowed for meeting urgent needs in short notice.

### Citizen Charter of the Bureau

- (i) Provide one-stop service for NGO activities
- (ii) Approve project proposals submitted by NGOs, release project funds, approve appointment of expatriate officials/ consultants & their tenures of service.
- (iii) Scrutinize and evaluate various reports & statements submitted by NGOs.
- (iv) Establish links among NGO activities, monitor, inspect & evaluate NGO Programs.
- (v) Realize Fees/Service charges fixed by the Government.
- (vi) Inspect NGO programs at field level & audit their income & expenditure accounts.
- (vii) Maintain liaison with donor agencies/NGOs.
- (viii) Examine the reports on the activities of NGOs and take necessary steps there on.
- (ix) Enlist Audit firms (Chartered Accountants) for auditing the NGO projects' accounts and review the audit reports.
- (x) Approve receipt of one-time contributions by NGOs.
- (xi) Obtaining opinion of different ministries/Divisions/ Departments on the NGO project proposals
- (xii) All other matters related to foreign donation receiving NGOs.

 (xiv) Checking money laundering &financing of terrorism by NGOs.




